Policy	Description/Background
Acupuncture	The management of chronic low back pain can take both pharmacologic and non-pharmacologic approaches. The mechanism of action of analgesia secondary to acupuncture is unclear, possibly multimodal. However, there are some physiologic effects that have been noted with its use. For example, it is thought that the immediate analgesic effects of acupuncture may be dependent on neural (nerve) innervation. Acupuncture has also been shown to induce the release of endogenous opioids in various parts of the brain. Local tissue effects including release of adenosine at the site of needle stimulation have also been observed as have increases in local

blood flow. Other modes of action have been reported including local and myofascial trigger point needling effects, segmental pain effects, extra-segmental pain effects, and central regulatory effects.

Medical Policy Statement: The Centers for Medicare & Medicaid Services (CMS) will cover acupuncture for chronic low back pain when criteria are met.
